

## GETSO Meeting Minutes October 20, 2008

Call to order at 8:10

Chairperson – Gibson

- √ Thank you to Deanna Salo for her dedication to ensuring a successful Fall Classic Tournament.
- √ Fields Update – Park District has indicated that GEFC should coordinate their facility requests and present them to the PD at the next meeting on Oct 28. Saguto to provide more info, but Keith wanted to reinforce with people that their help/participation will be welcomed.

GEPD – Evans

- √ Lockboxes installed in upper and lower Ackerman. 1 Key to be signed out for each team.

Field Update – Saguto

- √ Construction has begun. GEFC received less than 1 week notice that fields 2&3 would be taken away.
- √ Spring Configuration will involve 1 large field at Village Green and 2 U12 fields at Hadley
- √ Additional Facilities upgrades for consideration with Park District – These will require reinforcement and commitment from GEFC
  - Additional Lights, Irrigation, Better field maintenance,
  - Enforcement on use of the field by non-PD organizations.
- √ GEFC needs to mobilize its parental community to express and push the needs to the GEPD

Girls Coordinator - Howard

- √ Winter league – 8 girls teams registered at Glendale Heights
- √ Facilities have opportunities to rent fields for training
- √ Encourage participation in 1 day tournament – Freeze Out
- √ Brine Soccer balls available for teams that need a game ball.
- √ Request to ask in the evaluations for feedback on TinType vs. tournament photographer
- √ Soccer2K has offered to replace any uniforms with snags or socks that are too large

Co-Rec Coordinator - Dickson

- √ Teams must sign up for their own indoor league, if inclined.
- √ Winter training will involve 2 hour session, every other week.
- √ Encourage parents to complete the upcoming evaluations
- √ Discussion on process for adding players

- Agreement that requests should be forward to the coordinators for handling among the teams – not directly to the coaches.

Future Pros – Stivan

- √ Please bring any issues that coaches/parents have with trainers to Ruben.
- √ Indoor in the winter – teams may not have their normal trainer
- √ Future Pros is renting 2-3 days at the Hub in Glendale Heights – available to teams between 5:00pm and 8:00pm.

Tournament Results – Salo

- √ Tournament net'd \$21,000 in 2007
- √ Expected 2008 results to be significantly better
- √ Request that GEFC provide a gift to the church for parking/inconvenience. We did not gift in 2007, so this could be a “double”
- √ Salo will provide to GEFC additional gift requests: bus drivers and others.
- √ Allocation of funds to the teams to be calculated based on participation.

Chairperson – Gibson

- √ GEFC received a formal complaint from the referee coordinator, B. Impelido regarding the behavior of N. Howard towards a referee in the tournament.
- √ GEFC issued a formal warning to N. Howard. Repeat of behavior in the remainder of the season will result in suspension.

- √ UH t Coaches are good targets
- √ Retention is a major issue
- √ Zero-tolerance policy should be considered. Readers have One in place Rescheduling Issues-predetermined slots. Could make it easier on refs + field Coord.
- √ Need more entry level and recertification, Pay is \$25/game e for House,\$30-55 for travel

- √ Coordinator agreed to provide feedback on the behavior of both coaches + Parents
- √ Coordinator agreed to create a referee evaluation form for coaches to complete.
- √ General agreement that more feedback in both directions would be beneficial
