

GETSO Meeting Minutes December 15, 2008

Call to order at 7:07

Chairperson – Gibson

- Park District Board looking for \$200k contribution for lights at Ackerman. Has designated \$40k for Capital Expenditures.
- Coaches should encourage players to explore the Olympic Development Program (ODP) and the now equivalent program from NISL and US Club Soccer.
- Tournament Financials – \$98k of revenue, \$42.5k of income for the Club. Discussion allocate \$110-\$130 per player and leave \$4-\$8k cushion in the account.

Motion (Dickson, seconded - Mullins) : To designate \$110 per player, with remainder to stay in Club's account. Passed Unanimously.

Fields – Saguto

- 3 80x55 fields to go in at Hadley for the spring..for training and secondary game fields.
- Description of other field configurations.

Girls Coordinator – Howard

- 8 teams have signed up for Indoor with a Jan 4 start.

Boys Coordinator – Dickson

- Ruben has finalized the indoor practice schedule – 2 hour sessions on alternating Sundays.
- NISL has switched affiliations from Illinois Youth Soccer to to US Club Soccer.
- Coaches will need to renew their certificates at year end.
- Check NISL Website for Seeding and Scheduling meetings in Jan/Feb.
- ODP is Illinois Youth Soccer – Non-NISL. NISL equivalent will be to have teams identify players within each age group.
- Teams have the option for a 6-8-10 game schedule in the Spring.
- NISL is participating in “State Cup.” \$300 Fee for 3 guaranteed games, then a round robin play in the last 4-5 weeks of the season. Coaches to schedule games separately.
- Tryouts may begin after the Tuesday after Memorial Day.

Co-Chairperson – Gibson

- Presented for discussion only: Changes to the By-Laws. To be reworked and voted on at the January meeting.
- Discussion on the makeup of committees – Co-Chairperson appointed vs. Committee head selecting.
- Discussion on a statement on playing time. 2 versions submitted

- Discussion on the selection of the Head Coach
- Discussion on having the Head coach name the assistant, vs having the Coach Selection committee appoint the assistant coach.
- Encourage attendance at the January 12 District 87 School Board Meeting to support the Gain Ground initiative for Field Turf.
